

THRIVE FTC SINGLE USER ONLINE RESOURCE LICENCE

Thank you for your interest in our resource.

This licence agreement (**Licence**) is a legal agreement between you (**Licensee** or **you**) and Fronting the Challenge Limited (**Licensor, us** or **we**) for the Thrive Computer Programme (**Online Resource**), which includes associated software components and electronic and physical documentation (**Documentation**).

1. DEFINITIONS

1.1 The definitions and rules of interpretation in this clause apply in this agreement:

“Initial Support Services Period” the period of 3 calendar months commencing on the date on which the Online Resource is first used.

“Introduction Period” the 1 calendar month trial period commencing on the date on which the Online Resource is first used.

“Licence Key Activation Number” the code number that will be supplied by the Licensor or its supplier upon purchase of a Licence to use Online Resource.

“Normal Working Hours” the hours 9:00 am to 5:00 pm UK time, Monday to Friday, except English Bank Holidays.

2. GRANT AND SCOPE OF LICENCE

2.1 In consideration of payment by you of the licence fee (calculated by reference to the number of assessments requested) and you agreeing to abide by the terms of this Licence, the Licensor hereby grants to you a annual non-exclusive, non-transferable licence to use the Online Resource and the Documentation in the UK on the terms of this Licence. Any subsequent renewals of the Licence will be offered at a discounted rate, which will be determined at the Licensor's absolute discretion.

2.2 When you first obtain a licence to use the Online Resource, you are granted an Introduction Period / Free trial. This entitles you to use the Online Resource to thoroughly evaluate its usefulness and functionality before making a purchase. During this Introduction Period, the printing facilities within the programme will remain disabled.

2.3 After the Introduction/Free trial Period, if you wish to continue using the Online Resource, you must purchase and obtain a Licence Key Activation Number. Each Licence Key Activation Number is unique to you and is not transferable.

2.4 You may:

(a) use the Online Resource on a single computer, which is permanently located at the address given when registering with us; or on a portable or home computers of any staff member working at the registered users address. If such person ceased to work at the registered user's address, then such person's authority to use the Online Resource on a portable and home computer shall cease; and

(b) use any Documentation in support of the use permitted under condition 2.1. You are not permitted to make any copies of the Document. If you require further copies of the Documentation, this must be purchased from us.

3. LICENSEE'S UNDERTAKINGS

3.1 Except as expressly set out in this Licence or as permitted by any local law, you undertake:

(a) not to rent, lease, sub-license, loan, translate, merge, adapt, vary or modify the Online Resource or Documentation;

(b) not to disassemble, decompile, reverse engineer or create derivative works based on, the whole or any part of the Online Resource; and

(c) to supervise and control use of the Online Resource and ensure that the Online Resource is used by your employees and representatives in accordance with the terms of this Licence.

(d) not to provide or otherwise make available the Licence Key Activation Number to any person other than your employees without prior written consent from the Licensor.
